In the context of the [EU-OECD Project on Promoting Public-Private Dialogue in Libya](#), the OECD is organising a public sector dialogue on promoting economic reforms in Libya's agribusiness sector. The purpose of the meeting is to discuss the main challenges facing the sector with the aim of identifying policy priorities for economic transformation and private sector growth. Participants will be asked to provide their views on various issues, namely on improving the regulatory framework, improving the business environment, and increasing self-efficiency and export potential for the sector.

The [EU-OECD Project on Promoting Public-Private Dialogue in Libya](#) aims to support and encourage active economic and social dialogue between public and private sector actors by: 1) Creating a platform which mobilises public-private discussions through physical encounters; 2) Providing the government, private and social actors with the tools and expertise necessary to engage in a structured dialogue; 3) Contributing to developing a new economic vision for the country, delivering analytical inputs and well-structured and specific policy reform plans.

Format and guidance for the discussion

The discussion will be structured around three main challenges for the agribusiness sector. The discussion will be guided by an issues paper with a set of questions for participants and moderated by Tatweer Research. All participants will have the possibility to share their views through an open discussion.

- What policy instruments should be introduced to promote integration in agricultural value chains (e.g. quality certification, good agricultural practice, organic certification)?
- What policies need to be changed or implemented to conserve water and soil, better manage groundwater or improve water allocation?

Key questions for discussion:

- How can Libya promote use of technologies that support the sustainable management of water and energy by the agriculture sector?
- What measures need to be taken to promote innovation in the sector in order to integrate technologies or enhance production methods (e.g. R&D, capacity building)?

11:45 - 12:45 **Challenge III: Increasing food self-efficiency and export potential**

Open discussion with public sector

Key questions for discussion:

- Can Libya achieve self-efficiency in agriculture? What challenges exist to increasing food security?
- What areas or products represent a comparative advantage or high potential for export in Libya? What steps need to be undertaken to develop specific value chains that provide access to domestic or export markets?
